



GMAT Waiver Request Form

Prospective students applying to the online Master of Accountancy might be eligible to receive a GMAT Waiver. In order to be considered for a waiver, you must meet one of the criteria listed below:

- Undergraduate accounting degree from an AACSB accredited accounting program with a minimum 3.25 upper-level (3000 level or higher) accounting GPA.
- Undergraduate accounting degree from an AACSB accredited business school with a minimum 3.50 upper-level accounting GPA.
- Completion of online Auburn Accounting Bridge or Undergraduate Certificate in Accounting (UCA) program with a minimum 3.25 GPA.
- Completion of online Auburn Graduate Certificate in Accounting (GCA) with a minimum 3.25 GPA.
- JD, MD, PhD from a U.S. accredited institution.
- Advanced degree in business from an AACSB accredited business school.
- Successful completion of CPA exam.
- Relevant executive level experience (five years plus).

To apply for a waiver, submit your online Graduate School Application – including resume, statement of purpose, letters of recommendation, and official transcripts - and the form on the next page. The waiver should be emailed to allie.dyleski@auburn.edu. The Admissions Committee will evaluate all application materials to determine if a waiver will be granted. Meeting the minimum criteria does not guarantee a GMAT waiver or admission to the program.
